THE MINIMUM NECESSARY REQUIREMENT is a key protection of the HIPAA Privacy Rule. It requires healthcare entities, such as EverCare, to take reasonable steps to limit the use or disclosure of, and the request(s) of PHI, to the minimum amount necessary to accomplish the intended purpose.

COMPLIANCE MEANS doing the right thing; act fairly, honestly and use your best judgment by adhering to our policies. When in doubt, ask. Act in the best interest of EverCare and those receiving our care. For example, if a member of MLTC, is not receiving skilled services, you must bring it to the attention of your supervisor or my office.
