Absolutely Not!!! Do not EVER forward any company information, via non-EverCare approved channels, to your personal device or any other email address. This is not allowed. It is unsecure and a major compliance violation.

2] Do confidentiality protections apply to only health related information or also age, Social Security, an address or phone number under PHI? If you answered yes, you are correct!

MEDICAID SPEND DOWN defined: NYS allows an individual to subtract one's medical expenses from income to become eligible for Medicaid because of being "medically needy." The nursing home version of Medicaid is Net Available Monthly Income [NAMI] whereby a nursing home resident contributes toward the cost of her/his care.
